MEMBERSHIP SUBSCRIPTION AGREEMENT

1. Membership Packages

- Membership subscriptions are available in monthly access packages of **5, 10, 15, or 30 hours** of Wood Shop use **per month**.
- Members may select a subscription term of **3 months, 6 months, or 12 months**.
- The subscription term begins on the date of enrollment, with the first subscription payment due on the 1st of the following month. Any hours used between the date of enrollment and the first scheduled payment will be billed at the same hourly rate associated with the selected subscription package, and these charges will be applied to the payment method on file along with the first subscription payment.
 - *Example:* If a member enrolls mid-month and uses hours prior to the first billing date, those hours will be billed at the package hourly rate and included in the first billing cycle.
- Membership provides access to the tools, space, and community at Inspired Lumber Workshop. Additional rules will be covered under the Workshop Rules which all members are required to sign.
- Members receive the selected number of hours per month during their subscription term as outlined in their package.
- Hours DO NOT roll over between months unless otherwise specified.

2. Payments and Renewals

- Hours used between the date of enrollment and the first subscription payment will be charged at the hourly rate associated with the selected package and added to the first subscription payment.
- Hours used above the monthly subscription package will be charged at the hourly rate associated with the selected package and added to the next month's subscription payment.
- Member expressly authorizes Inspired Lumber Workshop to charge the payment method on file for all membership fees, overage charges, and any applicable fees.
- Memberships automatically renew unless cancelled in accordance with Section 6.
- Members will receive written notice of renewal 5–30 days before the renewal date.

- Additional fees for special projects, laser engraving, 1:1 tutoring, etc. will be charged at the time of service.

3. Cancellation

- Members may cancel their subscription at any time.
- Cancellation requires written notice to Inspired Lumber Workshop.
- Early cancellation will result in a fee equal to 25% of the remaining contract balance, not to exceed \$200.
- Cancellation requests will not result in refunds for prior months or partial use of membership hours.

4. Refunds

- Refunds are not offered under any circumstance for subscription payments or unused hours.

5. Overage Hours

- Any hours used above the monthly package allotment will be charged at the hourly rate associated with the selected package and added to the next month's billing.
- Overage hours are billed monthly along with the subscription renewal.

6. Taxes and Fees

- Sales tax is not applicable to memberships or classes in the state of Ohio.
- Sales tax may be added for services including 1:1 tutoring, artwork design and production, outside purchases of materials, etc.

7. Governing Law

- This Agreement shall be governed by and construed in accordance with the laws of the State of Ohio.

8. Acknowledgement

By signing below, the Member acknowledges they have read, understand, and agree to the terms of this Agreement, the Workshop Rules, and the Liability Waiver. The Member agrees to pay all fees, including overage charges and early cancellation fees, as outlined herein.
