company, and its owners, employees, successors, assigns, and agents (referr	red to herein as "V	Voodruff"); and
, the Member, volunteer, guest, or	attendee at a wo	rkshop or class
(referred to herein as the "Member/User") who has signed this Release.		

I, the Member/User, desire to participate in activities of the Company as a Member/User.

I understand that the activities may include but are not limited to meetings, construction of personal, group and/or community projects, on-site and off-site, and other related activities, either as a direct representative of the Company or as a participant in a Company sponsored event or as a volunteer or team.

- 1. Waiver and Release. I, the Member/User, release and forever discharge and hold harmless the Company and Woodruff from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my participation in classes, workshops, and the like with the Company. I understand and acknowledge that this Release discharges the Company and Woodruff from any liability or claim that I may have against the Company and Woodruff with respect to any bodily injury, personal injury, illness, death, or property damage that may result from my participation with any Company activities. I also understand that the Company and Woodruff do not assume any responsibility for or obligation to provide financial assistance or other assistance to me or for my benefit, including but not limited to medical, health, or disability insurance, in the event of injury, illness, death, or property damage. (See insurance requirements below.)
- **2. Insurance**. I, the Member/User, understand that the Company and Woodruff do not carry or maintain, and expressly disclaim responsibility for providing, any health, medical, or disability insurance coverage for the Member/User. EACH MEMBER/USER IS EXPECTED AND ENCOURAGED TO ARRIVE WITH MEDICAL OR HEALTH INSURANCE COVERAGE IN EFFECT.
- **3. Medical Treatment**. Except as otherwise agreed to by the Company and Woodruff in writing, I hereby release and forever discharge the Company and Woodruff from any claim whatsoever that arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my time as a Member/User.
- **4. Assumption of Risk.** I understand that my time as a Member/User may include activities that may be hazardous to me, including, but not limited to, construction activities, loading and unloading of heavy equipment and materials and the use of manual and powered high-speed wood cutting tools and machines. I recognize and understand that my activities may involve inherently dangerous activities. I hereby expressly and specifically assume the risk of injury or harm in these activities and release the Company and Woodruff from all liability for injury, illness, death, or property damage resulting from the activities of my time with any activities provided by the Company.

- **5. Photographic Release.** I grant and convey unto the Company all rights, title, and interest in any and all photographic images and video or audio recordings made by the Company during my activities, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.
- **6. Project Integrity.** I understand that the Company will provide all components for project construction for classes only, unless otherwise stated, and will make every attempt to ensure project continuity while under guidance in classes the Company, however, cannot be held responsible for completed projects with regard to personal choices made during construction or structural integrity after projects have left the premises.
- **7. Other.** I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Ohio, and that this Release shall be governed by and interpreted in accordance with the laws of this State. I agree that in the event that any clause or provision of the Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of the Release, which shall continue to be enforceable.
- **8.** Indemnification of the Company and Woodruff. I understand that, to the extent provided by law, the Company and Woodruff shall not be liable for any damage or injury to any Member/User or any other person, or to any property, occurring on the Company premises located at 3156 W. Central Avenue, Toledo, Ohio 43606 (the "Premises") or any part thereof. I agree to indemnify, defend, and hold harmless the Company and Woodruff from any and all claims pertaining to any damages and injuries which may arise in connection with any related uses of the Premises. Said indemnification shall include indemnity for any costs or fees which the Company or Woodruff may incur in defending any such claim. Further, I agree to indemnify the Company and Woodruff for any damages incurred in any way by the Company and Woodruff as a result of the actions or omissions of any Member/User or any person affiliated with or under the supervision of Member.
